

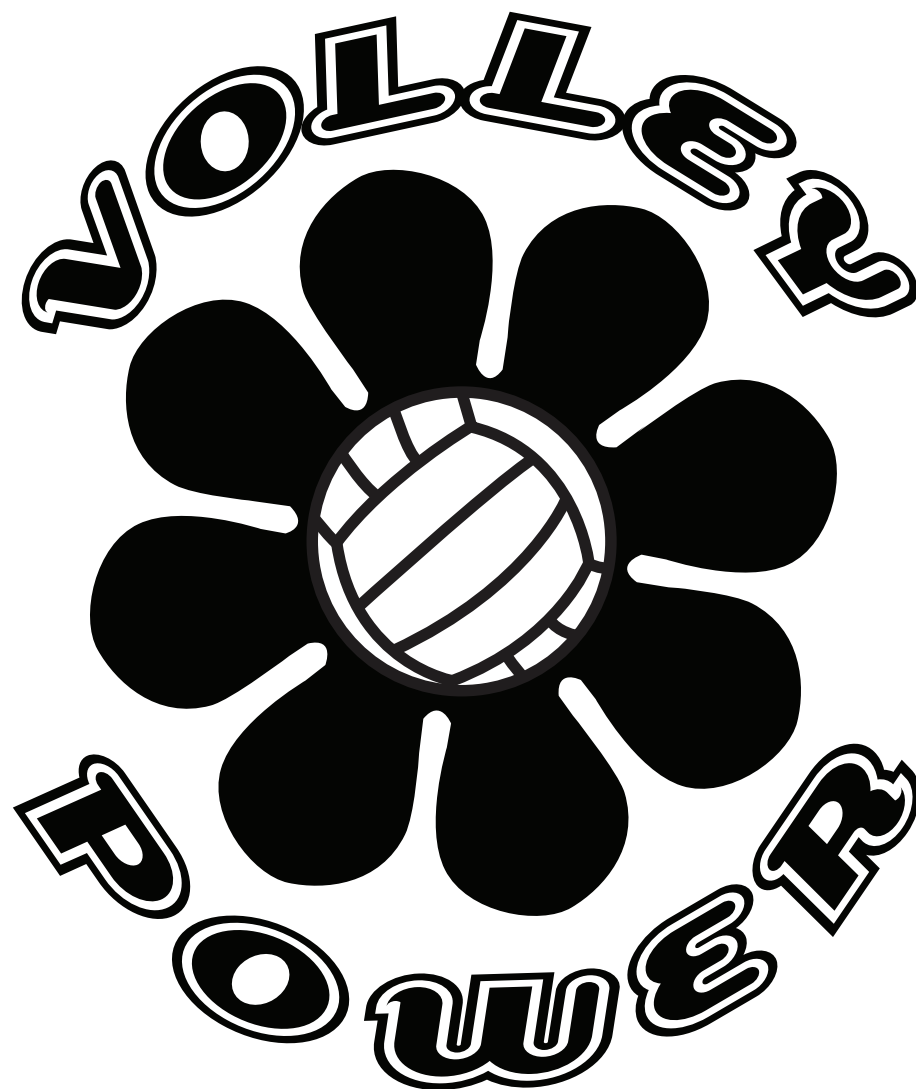

In addition, instruction on offensive and defensive rotations will be presented. This session is designed for the competitive player with over 2 years of experience. (Incoming 7th - 8th grades)

This is a camp that will focus on the basic skills of volleyball. We will work on the fundamentals, including serving, passing, setting and spiking. Camps will be lead by Genevieve Dittmar and Wendy Munzel and assisted by other coaches and collegiate players.

Wendy Munzel has been club director of Dallas Juniors Club for 11 years and coached for 9 years. She spent 8 seasons at Ursuline Academy as the varsity head coach and her team won the District 1-5A title in 2001 and 2003 as well as earning her the Coach of the Year honor. She has coached volleyball for 18 years. Wendy played middle blocker for Division I University of Houston and has coached at the Division I level as well as High School and Club levels.
